June 14 is Flag Day–a mandatory service for the Elks. In 1907, the Elks became the first fraternal body to adopt by Resolution that June 14 be designated as Flag Day in our Order. President Woodrow Wilson established a national Flag Day in 1916 by presidential proclamation. In 1949, President Harry Truman, himself an Elk, signed an act of Congress designating June 14 each year as Flag Day.

The American flag symbolizes the "land of the free and home of the brave" for all Americans. As we pay tribute by proudly displaying our American flag, let us rededicate ourselves to the ideals of patriotism and freedom.

On Sunday, June 16, we observe Father's Day. We recognize fathers and grandfathers for their contributions to fatherhood. The first Father's Day was

# A Boost does wonders for Voluntary Service programs

A few years ago, the Elks National Veterans Service Commission began offering Boost Grants to Voluntary Service Representatives who planned projects that go above and beyond their typical monthly activities. This grant was created to build on the experience that current Elks volunteers have and the relationships they have formed with the veterans they serve every day.

When the VA in Manila, Philippines requested blood pressure monitors to help veterans maintain their health after their appointments, Voluntary Service Deputy Representative Aaron Key stepped up to provide therapeutic archery lessons. This provide them. He continued the project activity makes a great addition to other this year with funding from a Boost Grant.

In addition to the monitors, veterans are included in an educational event where they learn how to use the monitors and discuss the importance of tracking their symptoms. Key said that this type of project is important because it can extend and improve veteran lives.

At the South Orange County Vet Center in Mission Viejo, California, Voluntary Service Representative David Perry decided to apply for a Boost Grant to recreational and social programs

Perry hosts, like lobster fishing trips, football watch parties, axe throwing, and other activities.

Dennis Carmack is the Voluntary Service Representative at the VA hospital in Poplar Bluff, Missouri. During his visits at the hospital, he noticed

that veterans loved spending time looking at photos he had taken of their activities. This led him to apply for a Boost Grant to start a photography program.
